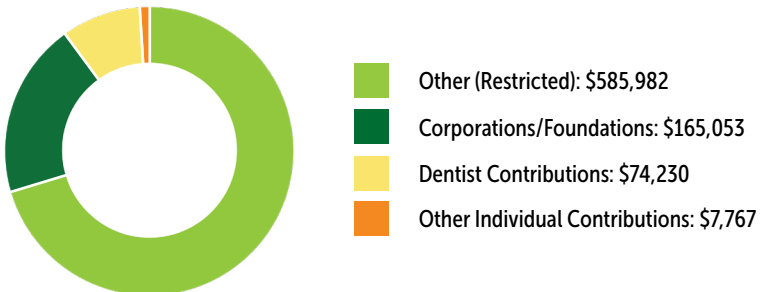

2023 FLORIDA MISSION OF MERCY

The signature philanthropic program of the Florida Dental Association (FDA) Foundation, *Florida Mission of Mercy (FLA-MOM)*, is the state's largest charitable dental clinic that provides care to any patient at no cost, with the goal of serving the underserved and uninsured in Florida – those who would otherwise go without care. Since its inception in 2014, *FLA-MOM* has provided \$14.67 million in donated services to 13,816 patients, with the help of 12,854 volunteers.

The 2023 *FLA-MOM* was held Feb. 24-25 in West Palm Beach at the Expo Center at the South Florida Fairgrounds. More than 2,000 volunteers provided \$1.85 million in donated care to 1,327 patients. The clinic provided oral health education, dental evaluations, oral cancer screenings, X-rays, extractions, fillings, root canals, cleanings and immediate dentures and partials. In addition, *FLA-MOM* provided a resource guide of local and regional community dental programs and clinics for patients to access routine care. Patients attending the clinic were encouraged to participate in the *FLA-MOM Impact Study* to gather information about their dental and general health, reasons for delaying dental care and their use of local hospital emergency departments for their pain.

DONATED DENTAL SERVICES

Donated Dental Services (DDS) is a program jointly funded by the FDA Foundation and Dental Lifeline Network • Florida. *DDS* provides access to comprehensive dental care for people with disabilities or who are elderly or medically fragile and cannot afford treatment. Since 1997, Florida *DDS* has provided \$11.1 million in donated dental care to 2,182 patients.

DISASTER RELIEF

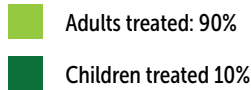
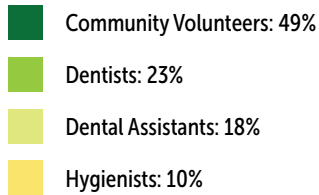
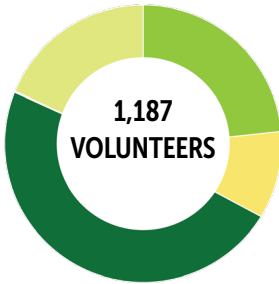
Florida dentists impacted by a disaster can apply for emergency disaster grants to help meet their personal needs such as food, water, clothing, emergency shelter, medications etc. In September 2022, Hurricane Ian made landfall in the Fort Myers area as a Category 4 Hurricane, devastating Southwest Florida. To supplement the Disaster Fund, the FDA Foundation received \$17,470 from individuals and \$149,000 in donations from Florida Dental Association Districts and other state dental associations to help meet the needs of dentists affected by the hurricane. In response to the impacts of Hurricane Ian, the FDA Foundation processed **209** disaster grant applications and provided **\$313,500** in grant funds.



PROJECT: DENTISTS CARE

Project: Dentists Care Inc. (PDC) is a statewide network of organizations that offer preventative and restorative dental care to those in greatest need. The FDA Foundation maintains a comprehensive list of dental access programs throughout the state in the *Project: Dentists Care Resource Guide*. These programs are eligible for annual grants from the FDA Foundation. Over the last eleven years, *PDC* programs have provided treatment to 75,565 patients, resulting in more than \$45 million in donated dental care.
